## **Addendum to Circular dated 03.01.2025**

### **Subject: Conduct of Limited Departmental Competitive Examination for the posts of SSO, Assistant/Head Clerk, UDC/UDC - Cashier, PA and LDC in ESIC regarding .**

In continuation of circular dated 03.01.2025 issued by this office regarding the subject cited above, the following information is added to the above circular after the approval of the Regional Director, RO Delhi:

#### **1. Promotion Consideration for juniors and seniors**

Where Juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less and have successfully completed their probation period, for promotion to the next higher grade along with their juniors who have already completed such qualifying eligibility service.

#### **2. Eligibility for LDCE of LDC Cadre (Haryana Region)**

Paramedical staff eligible for the LDCE for the post of LDC as per the Recruitment Regulation, from the Haryana Region (namely ESI Hospital, Faridabad/Gurugram/Manesar) may apply for the said post in the D(M)D region only.

#### **3. Eligibility for IRT Candidates in Delhi Region**

In respect of officials who joined the Delhi Region through IRT, it is informed that candidates fulfilling the criteria as per the extant IRT policy conditions will be eligible to appear in the forthcoming LDCE for promotion to the posts of LDC, UDC, Assistant/HC, Stenographer, and PA.

**Those who have already applied for the LDCE need not apply again.**

All other contents of the circular dated 03.01.2025 remain the same.
